**SECTION A – NATIVE INDIANS**

Under the Indian Act (Canada), Native Indians are not subject to Goods & Services tax and provincial taxation on telecommunication services acquired on reserve or designated reserve land.

**SECTION B – BANDS**

Under the Indian Act (Canada), Native Indian Bands are not subject to provincial taxation on telecommunication services acquired on reserve or designated reserve land. Bands acquiring telecommunication services for band management activities are not subject to Goods and Services Tax.

In order to verify that your account is eligible for tax exemption, we are requesting that you provide us with the following information, whichever is applicable.

**SECTION C – BAND EMPOWERED ENTITY**

**Band-empowered Entity** - A corporation, board, council, association, society, or other organization that is **owned or controlled** by a band, a tribal council, or a group of bands other than a tribal council. Band-empowered entities may acquire telecommunications services without being subject to tax if the services are acquired for band management activities.
