**IMPORTANT:**

To obtain the rebate claimed, you must provide a document (not a photocopy) certifying payment of the QST, that is,

- the confirmation of service obtained at the SAAQ office;
- the purchase contract respecting the vehicle in question, or the receipt issued by the vendor.

Refer to the corresponding section of this form to find out what additional documents must be provided.

**A – Transaction involving an amount below the appraised value of the vehicle**

A transaction involving an amount that is below the appraised value of the vehicle may take place only if the vehicle is damaged or has been subjected to unusual wear.

**Note:** No later than 10 working days after the date on which the road vehicle is supplied, you must obtain a written estimate (of the repairs necessary or the value of the vehicle) from an adjuster recognized by the Groupement des assureurs automobiles. The estimate must be enclosed with this form. Your application will not be considered if the estimate is carried out after the prescribed time period.
