 - The agreement focuses on implementation strategies, dispute resolution mechanisms, and a long-term funding commitment of \$8.5 billion over nine years.

 - Additionally, the approval of the Ontario Final Agreement remains contingent on the Tribunal's decision, with a targeted implementation date of March 31, 2026. Should Tribunal approval not be secured by this deadline, there will be significant funding implications for the 2025-26 fiscal year.

- Trilateral Agreement on the Reform of the 1965 Agreement (Five-Year Term) Mohawk Council's exemption from the 1965 Agreement.
- Agreement on First Nations Representative Services for Off-Reserve Funding (Two-Year Term).

Funding Commitment:

• A total of \$8 billion will be allocated over nine fiscal years, from April 1, 2025, to March 31, 2034. Additional funding will be provided to support administrative functions, cultural humility training, program evaluations, and legal expenses.



Funding Outlook for 2025-26:

- Both Agencies (ACFS) and First Nations (MCA) will have access to multiple funding streams, including allocations for prevention, emergency response, and capital expenditures.
- Funding adjustments will be made as necessary to account for remoteness and regional needs.

First Nation (MCA) and Agency (ACFS) Funding:

• First Nations (MCA) will receive direct funding for essential services, including prevention initiatives and post-majority support programs. Agencies (ACFS) will continue to receive funding from both Ontario and the FNCFS Program (ISC) to support prevention, operations, maintenance, and emergency services.

- Public Service the Family Well Being program, a \$35.4 million initiative launched in 2016 to support Indigenous communities.
- The program serves 84,000 people across 198 communities, with 60% identifying as women or girls. Services include culture-based activities, wellness programming, and mental health support.
- Challenges include staffing, funding constraints, and compensation. The program received a 2% budget increase, but it was insufficient for the need for more funding and better salary standards to retain staff and improve services.

- COO Important Update on the Ontario Final Agreement Canadian Human Rights Tribunal (March 28, 2025)
 - The Chiefs of Ontario and Nishnawbe Aski Nation are hosting an important meeting to provide updates on the Final Agreement on Long-Term Reform of the FNCFS Program in Ontario (Ontario Final Agreement), the Trilateral Agreement on Reforming the 1965 Agreement (Trilateral Agreement), and the Canadian Human Rights Tribunal (CHRT) case status.

NEXT STEPS:

- Continue advocating for the proper distribution of the \$8.5 billion child welfare funding and monitor the Ontario Final Agreement approval process.
- Prepare for the May 1, 2025, Governance Table Meeting in Toronto to address border crossing concerns, ID requirements, and safety/security measures.
- Follow up on the Akwesasne Legislative Enactment Procedure Regulations (ALEPR) process to ensure clarity in law-making and governance.



- Work with the Emergency Measures Team to refine disaster response strategies and preparedness plans for Akwesasne.
- Continue hosting informational sessions and district meetings to update the community on governance, funding, and policy changes.
- Address community concerns regarding tariffs, fishing regulations, and new recreation building needs.
- Track progress on the Trilateral Agreement on Reforming the 1965 Agreement and ensure First Nations' exemptions are honored.
