## **SUMMARY OF RESPONSIBILITIES:**

Under the supervision of the Supervisor, and In Charge EMT, the Emergency Medical Technician carries out a range of pre-hospital Emergency Medical Care to the sick and injured in accordance with all state, local applicable laws, regulations and protocols (NYS DOH, NYS Mountain Lake regional medical protocols and AMA SOP's) The EMT is responsible for the daily duties of the ambulance service by assessing and treating patients; transporting patients to and from Health Care Facilities; preparing and submitting reports; safely operating EMS vehicles and ensuring the stocking and safeguarding of vehicles, equipment, supplies and medications; etc. Must obtain and maintain "on line" status as an EMT. The EMT is a mandated reporter of the vulnerable people sector.

The EMT must demonstrate competency in assessment of a patient, handling emergencies using basic life support equipment and techniques. Must be able to perform CPR, control bleeding, provide non-invasive treatments, hypoperfusion, stabilize/immobilize injured bones, manage environmental emergencies, and emergency childbirth. Must be able to use semi-automatic defibrillator. Must be able to assist patients with self-administration pr administer emergency medications as described in the state and local protocols.

## **QUALIFICATIONS:**

- High School Diploma.
- Valid NYS EMT Certification
- Valid CPR Certification
- Preferably one years' experience in the EMS Field;
- Must abide by the MCA Fleet Policy to be able to drive an MCA Vehicle (Must possess a valid drivers license, Class D in NYS, Ontario Class G, or Quebec 4A and have a reasonable driving record;
- Must obtain a clear level 3 Criminal Background Check (CPIC)
- Position required to work with the Vulnerable Sector.
