Important Information

Youth participants will be accompanied by adult chaperones consisting of police officers and civilian staff. 2-3 Elders from across Ontario will also be in attendance to provide guidance and support as needed. Should a youth participant fall ill, get injured, or be required to terminate the trip early, each service will do their best to have an adult chaperone accompany them home.

Youth participants will spend some time outdoors during some site visits. It is recommended they bring with them comfortable clothing suitable for summer weather conditions. They will also perform some physical activities outdoors. Recommended items to pack in their luggage are listed below.

Recommended Items to Pack in Luggage:

- Weather-appropriate clothing
- Athletic-type clothing for physical activities
- Comfortable shoes for walking/running/climbing
- Swimwear (in the event participants go swimming TBC)
- Personal hygiene products
- Medications
- Health Card

Airlines permit passengers to bring one (1) carry-on bag to take with them on board and one (1) checked bag/luggage that is stored in the aircraft. It is expected that they will accumulate additional items during the trip to take home. Therefore, they should leave extra room in their backpacks or luggage. Youth participants will also be provided with 2-5 t-shirts each to wear during the week depending on size availability. They will also be provided with a water bottle, baseball cap, and backpack once they arrive in Ottawa.

Airline Rules for Items in Carry-On Bags:

- Recommend powder-like substances over 350 mL (12 oz.) be stored in your checked bags.
- This includes baby powder, foot or body powder, baking powder or soda, protein powder, dry shampoo and powder detergent.
- Powders in carry-on baggage may require secondary screening, and those that cannot be clearly identified by security officials will not be allowed into the cabin.
- If you travel with liquids or gels in containers over 100mL/100g (3.4oz) in your carry-on baggage you will have these items confiscated at the security checkpoint. Make sure your carry-on containers for liquids/gels are less than 100mL/100g (3.4oz).
- Containers are to be placed in one (1) clear, closed and re-sealable plastic bag no larger than 1 litre (1 quart).
- One re-sealable plastic bag per passenger is permitted.

Domestic Flights – ID Requirements

All travelers on domestic flights must adhere to the following:

- Show one of these documents at the boarding gate:
 - one piece of photo identification issued by a Canadian federal, provincial or territorial government with your full name and date of birth or
 - o two pieces of identification issued by a Canadian federal, provincial or territorial government. Both must have your name and at least one must have your full name and date of birth.
- Here are some examples of acceptable Canadian government-issued identification documents:
 - passport
 - o citizenship card
 - Canadian permanent resident card
 - Canadian provincial or territorial driver's licence
 - Canadian provincial or territorial health card
 - Canadian provincial or territorial government identification cards
 - o birth certificate
 - Record of Landing Form/Confirmation of Permanent Residence (IMM 5292)
 - immigration documents issued to foreign nationals (e.g., Work Permit,

- Study Permit, Visitor Record, Temporary Resident Permit, Refugee Approved Status)
- o Canadian military identification
- o federal police identification
- federal or provincial government employee identification cards
- Old Age Security (OAS) identification card
- Certificate of Indian Status (Status Card) issued by Indian and Northern Affairs Canada
- NEXUS card
- o firearms licence
- Acceptable Canadian government-issued identifications documents must be valid. They cannot be expired.

Code of Conduct

We are excited to have you join us on the upcoming Emergency Management Indigenous Youth Career Initiative trip! In order to ensure everyone's safety and enjoyment, we kindly ask you to read and adhere to the following code of conduct. Please review it carefully and return a signed copy to your chaperone/organizer before the trip.

As representatives of their communities and of the police services that they are affiliated with, you are expected to conduct yourselves respectfully and be always mindful of youth personal safety which includes adhering to rules provided by chaperones and instructors. The success of this trip may result in a yearly trip for Indigenous youth across Ontario.

As such, all youth participants must review and sign this Code of Conduct form. Failure to do so will result in their registration being cancelled.

Respect for Others:

- Treat all participants, including fellow youth participants, teachers, chaperones, and guides, with respect, kindness, and courtesy.
- Listen attentively to instructions provided by teachers, chaperones, and guides and follow them promptly.

Safety and Security:

- Follow all safety guidelines and rules set by the organizers and the destination.
- Stay within designated areas and avoid wandering off alone or with unauthorized individuals.
- Report any concerns or hazards to a chaperone immediately.

Personal Behavior:

- Maintain appropriate behavior at all times, refraining from disruptive or disrespectful actions.
- Avoid using foul language or engaging in any form of bullying, harassment, or discrimination.
- Be mindful of personal hygiene and dress appropriately for the occasion.

Responsibility:

- Take care of personal belongings and organization property.
- Do not engage in any form of vandalism, theft, or unauthorized possession of items.
- Participate actively and positively in all activities and discussions during the trip.

Communication:

- Stay with the assigned group at all times and inform a chaperone if you need to leave temporarily.
- Be attentive during presentations, guided tours, and educational activities, and ask questions when appropriate.
- Use electronic devices, if allowed, responsibly and only during designated times or with permission.

Emergency Procedures:

- Familiarize yourself with emergency procedures and follow instructions provided by chaperones or guides in case of an emergency.
- Stay calm, cooperate, and assist others if necessary, during evacuation or emergency situations.
