Prologue:

General Meetings are to occur the last Thursday of each month and will occur in each district on a rotating basis in Kawehno:ke, Kana:takon, and Tsi Snaihne.

The exception to this is with the General Meeting Cancellation Protocol: MCR 2015/2016 - #260 *In the unfortunate circumstance where a community member passes in one of the three districts, the meeting will occur as regularly scheduled in the other two districts where the member did not reside. A moment of silence will also be taken in their memory.*

The General Meetings are an opportunity for Community Members to hear information from Council and assist Council with issues that affect the community.

The following General Meeting Rules were originally developed at a community General Meeting in July of 2006. The principles for 'General Meeting Rules' is based on respect for each other, and all attendees are expected to behave respectfully and professionally at all times.

General Meeting Rules:

1. Meetings will start at 6:00 p.m. and proceed to a maximum of 8:00 p.m. at which point the community will be asked if they choose to continue past 8:00 p.m.
2. Personal issues will not be dealt with in a public forum/General Meetings. Personal items can be dealt with on an individual basis with Council Members (or by appointment through the Mohawk Government Office).
3. If you have questions or comments during the meeting – raise your hand and wait to be acknowledged by the Chairperson. The Chairperson will keep note of the order that community members indicate to be acknowledged.
4. Please keep the questions and comments relevant to the point of order within the agenda and be considerate of the time used.
5. A list will be made of issues you wish to address to Council and if the answer cannot be provided at the current meeting, the issue will be taken back to Council table for further discussion and follow-up.

I hope everyone had a safe and happy holiday season enjoying time with family and friends! With the new year, we renew our commitments to one another and the responsibilities ahead. As we move forward, there are many important matters to bring to the community in a timely and respectful way. To support this, Council and Administration are working diligently to improve communication and better engage with community members.

You may notice changes in the formatting of our monthly reports as we work to balance the needs of those who prefer concise updates with those who seek more detail. Our written monthly reports are now in bullet format for a streamlined flow of information, complemented by more in-depth community notices on key topics, shared electronically and in a monthly publication delivered to households. Looking ahead, we are working to make more detailed information accessible to all members through a member's portal, and in April 2025, Council will begin live-feed updates. These efforts reflect our ongoing commitment to transparency and community engagement, which is why you will also see more Council presence at elder and youth gatherings as another way to strengthen connections. We hear you, and we are responding.

This month, we are excited to share updates on new services, including the opening of a clinic in Snye District at Iakhihsohtha Lodge. This long-awaited service brings primary care, blood work clinics, immunizations, diabetes prevention and care programs, Jordan's Principle services, and mental health appointments closer to home. We have also been meeting with the Canadian Border Services Agency (CBSA) to address ongoing border crossing concerns and stay ahead of community safety issues. Additionally, we are preparing to respond to the negative impact of the recent toll increase by engaging with corporations to find solutions that meet both the needs of our community and necessary maintenance provisions.

We also celebrate important milestones, including the signing of the new Tsikaristesere Trustee Board and the swearing-in of the new Chief Electoral Officer, marking a step forward in serving the needs of our people. A special thank you goes out to our Communications team for their prompt responses during critical moments, such as the recent power outages, and to the Snye Homemakers and volunteers who opened the warming center and provided hot meals to those in need. Their kindness and dedication reflect the heart of our community and the spirit of coming together.

As we look ahead, I look forward to February's Winter Carnival and hope to see everyone there—because "A family that plays together stays together!"

During this period, I attended all my required MCA Council and Portfolio meetings, remaining actively engaged in discussions and decision-making. I'd also like to extend my warmest wishes to the community and hope everyone had a relaxing and happy holiday season. I took two weeks off over the holidays to spend time with family and was recently out of the office on bereavement.

Iroquois Caucus Harvest Working Group

- **Location:** Tyendinaga, ON

Day 1 (Prep for Meeting)

- **Hunting Rights:** Discussed hunting outside treaty areas and the establishment of acknowledgment letters for native hunters.
- **Butcher Protections:** Drafted letters to protect butchers from potential Ministry of Natural Resources (MNR) charges.
- **Deer Population Management:** Addressed herd reductions around Akwesasne and Six Nations' traditional territories. Other areas within Parks Canada are being explored.
- **Treaty & Hunting Summit:** Brief discussion of the One Dish One Spoon 1701 Treaty and the upcoming hunting summit in Oneida.
- **Mi'kmaq Hunting Protocols:** Finalizing protocols, aiming for completion by next hunting season.
- **Tyendinaga's Fisheries:** Discussion on their ocean and fishery initiative (a hatchery to support the walleye population in the area).
- **Legislative Review:** Brief discussion on Bill C-53 and Métis assertions, with further consultations planned.

Day 2 (Meeting with Deputy Minister of Natural Resources)

- **Key Topics:** Covered trespass/property law, shipment letters, inherent rights, and treaty relationships.

- **Cultural Sensitivity Training:** ARRO presented their cultural awareness training that is available to MNR.
- **Acknowledgment:** Chief Vince commends the newly elected MCA chiefs in attendance for their active participation and strong representation of Akwesasne throughout the discussions.

Iroquois Caucus (IC) General Assembly

- **Location:** Ottawa, ON (prior to AFN Special Chiefs Assembly)
- **Jay Treaty Rights:** Discussed with Ontario Regional Chief (ORC) Abram Benedict and AFN National Chief Cindy Woodhouse Nepinak in attendance.
- **Grand Chief Introduction:** Introduced Grand Chief Leonard Lazore to IC communities.
- **Harvest Working Task Group:** Provided an update on the group's meeting with MNR.

Eel Knowledge Working Group

- **Location:** Virtual
- **Eel Release:** Working group established following up eel release event held by the MCA Environment Program in July 2024.
- **Data Sharing:** Canadian Wildlife Federation presented data on eel monitoring and the impact of Ontario's 953 dams.
- **Conservation Efforts:** Ongoing initiatives to support eel populations, which are critical to the ecosystem.

ARRO Portfolio Meeting

- **NYS Land Claim:** Discussed key points prior to settlement signing. Update on the letter presented to court regarding MCA's position on the land claim.
- **Referendum Planning:** Briefing on the referendum process and next steps.
- **Cairn Island:** Addressed media release request and response.

- **Year-End Review:** Summary of Nation Building's completed work.
- **Community Survey:** Discussed survey on Entewetatha:wi Self-Government Agreement (ESGA) and Nation Building's current initiatives.

- **Trust Update:** Trustees, overseers, Council, and Deloitte representatives received an update on the current trust amount and proposal priorities.
- **New Council Briefing:** Provided new Council members with an overview of the Trust's "dos and don'ts."

Economic Development Portfolio Meeting (December)

- **Quebec Political Protocol:** Discussed potential impacts of the proposed French language bill.
- **Agreements Review:** Evaluated existing agreements with Quebec and the creation of a framework to assess impacts on commerce in Quebec districts.

Border Partners Meeting

- **Traffic Flow & Turkey Giveaway:** Reviewed logistics and allowances for the MCA turkey giveaway.
- **Port Hours:** Smaller ports reduced hours; no impact on Dundee port of entry (POE).
- **Safety Measures:** Speed bumps installed in the northbound lane for enhanced safety. MCA presented public safety concern; USCBP responded that it's designated for the safety of officers conducting routine traffic checks.
- **CBSA Updates:** Discussed the medical transport MOU initiative and I was introduced to the new representative of CBSA: Acting Chief of Operations Chantale Nicholls and Regional Director General Jag Johnston.
- **Wildlife Protocols:** Addressed measures to mitigate issues such as Chronic Wasting Disease in deer.

AMPS Policing Initiative Presentation

- **Organized Crime Unit:** Akwesasne Mohawk Police presented on updated agreements for border enforcement response and organized crime reduction.

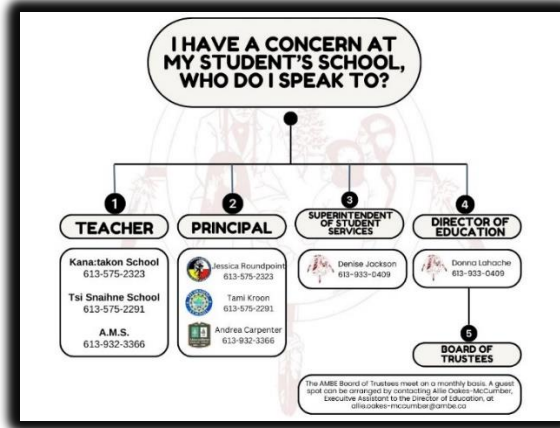

Vision: To implement the inherent right of self-government of the Mohawks of Akwesasne through the Akwesasne-Canada Entewatathá:wi Self Government Agreement.

Annual Update was provided to the Portfolio Chiefs on Tsiothórrha/December 10, 2024. Information on the project was very beneficial, especially for new Portfolio Chiefs.

The next **Portfolio Meeting** is scheduled for Enníska/February 5, 2025.

What is the purpose of the Entewatathá:wi Self Government Agreement (ESGA)?

The purpose of ESGA is to achieve legal recognition by the Government of Canada of the jurisdiction, authority, and institutions of the Mohawks of Akwesasne. Once the ESGA is ratified, Parliament will adopt legislation that will give ESGA the force of law. The legislation will be binding on the Government of Canada and the provinces. The legislation will terminate the application of many of the provisions of the Indian Act which represents a colonialist vision of limited self-government that is inconsistent with the inherent jurisdiction of the Mohawks of Akwesasne.

AJD employs the principle of natural justice to empower the community to safeguard collective rights, primarily, and individual rights for Akwesasró:non, while remaining respectful of the community's heritage and culture.

The **Akwesasne Justice Department (AJD)** is recognized as a first in Canada as a justice system that is based on customary laws which incorporate traditional restorative principles in the three (3) main responsibilities of government: Law Making, Adjudication and Enforcement.

Portfolio Meetings were held on Tsiothóhrha/December 17, 2024 and Tsiothohrhkó:wa/January 9, 2025. The portfolio also includes participation in **Oversight Committee on Legislative Development (OSC)**. The Committee meets with the Legislative Services Manager and its sole responsibility includes review of community laws. There will be a community survey forthcoming that will gain input and ensure that Akwesasne Laws reflect the values, customs and aspirations of Akwesasronon, as well as keeping with the principles of the AJD. RIBBON-CUTTING CEREMONY CELEBRATES OPENING OF SATELLITE TSI SNAIHNE MEDICAL CLINIC

Despite the frigid temperatures, the ribbon-cutting ceremony for the Tsi Snaihne Medical Clinic (TMC) radiated warmth as years of hard work and dedication finally came to fruition. This milestone event, held on January 22, 2025, marked the official opening of the much-anticipated



satellite clinic, a significant step in bringing healthcare services closer to the residents of Tsi Snaihne.

MCA Grand Chief Leonard Lazore commended the perseverance and teamwork of everyone involved. "This clinic represents a major step forward in ensuring the

residents of Tsi Snaihne have access to vital healthcare services close to home. It is a testament to the hard work of the Department of Health, the Health Portfolio Chiefs, and all those who have worked tirelessly on this project."

It was only fitting that Karen Loran had the honor of cutting the ribbon. As a former Tsi Snaihne District Chief and Health Portfolio holder, Karen worked tirelessly over the years, advocating and lobbying for this initiative. Her participation in the ceremony symbolized the culmination of years of dedication and commitment to making this vision a reality.

The Tsi Snaihne Medical Clinic will temporarily operate out of a dedicated space in Iakhihsohtha Lodge, with its entrance located at the far end of the building. To ensure the safety of Iakhihsohtha residents, the clinic has a separate, secure entrance, designated parking, and strict safety protocols.

This design ensures that patients and residents can benefit from this service without compromising health and safety.

The TMC will provide a variety of services, including primary care, blood work clinics, immunizations, diabetes prevention and care programs, Jordan's Principle services, and mental health appointments.

OFFICIAL SIGNING CEREMONY FOR TSIKARISTISERE TRUST

The Mohawk Council of Akwesasne is proud to announce the successful signing ceremony of the Tsikaristisere Trust, which took place on Thursday, January 23, 2025, at the Tsi Snaihne Recreation Center. This event marked the formal establishment of the trust, with Trustees and Council members officially signing the documents in the presence of community members.

In 2015, Canada presented a Land Claim Settlement Offer to the Mohawks of Akwesasne, including the opportunity to reclaim 18,282 acres of land through Canada's Additions to Reserve Process and a monetary settlement of \$239,808,436.00. This settlement addressed claims related



to the historically leased lands known as Tsikaristisere, or 'Dundee.'

Following negotiations, the final agreement was put to a referendum vote, conducted online and by ballot from October 1 to December 8, 2018. The community approved the settlement, with the results validated on

January 7, 2020.

The creation of the Tsikaristisere Trust marks a major milestone in this journey, reflecting a commitment to responsibly manage the settlement's resources. The Trustees are tasked with holding, managing, and investing the Trust Property in accordance with the terms of the agreement for the benefit of the Beneficiaries. A primary priority of the Trust is the purchase of land to be set apart as reserve land for the Mohawks of Akwesasne under Article 3.2 and 5.0 of the Settlement Agreement and additionally, through community consultation, the following areas were identified as community needs and priorities:

- Land management activities and programs, including the Additions to Reserve process;
- Education or training;
- Advancement of culture, heritage, and/or language;
- Environment;

- Green energy initiatives;
- Economic development;
- Housing;
- Indigenous rights;
- Infrastructure;
- Public safety;
- Emergency;
- Social welfare, health, and/or wellness;
- Sports, recreation, and/or the arts; or
- Other essential public services.

Since the initial payment from Canada, the settlement fund has been in the RBC and as of December 31, 2024, is now valued at \$259,683,600.93. These funds are now able to be transferred to the Tsikaristisere Trust, where they will grow at a significantly quicker pace.

Grand Chief Leonard Lazore addressed the significance of the moment, stating: "Tonight marks a milestone in our journey to reclaim what rightfully belongs to our people. This trust represents more than just a financial step; it embodies our people's rights, our collective vision for the future, and the power of what we can achieve when we come together."

Acting Executive Director Shannon Roundpoint added: "When Akwesasne began discussions on the settlement of the Tsi Karistisere claim, the return of land and access to funds for important community needs were the driving hopes that are now becoming a reality. Thank you to the trustees for stepping up into a role that will pave the path for future generations; it will be rewarding for them as well as the community. We also extend our appreciation to the community members who have stayed engaged in this process, and to the technical team for their hard work." 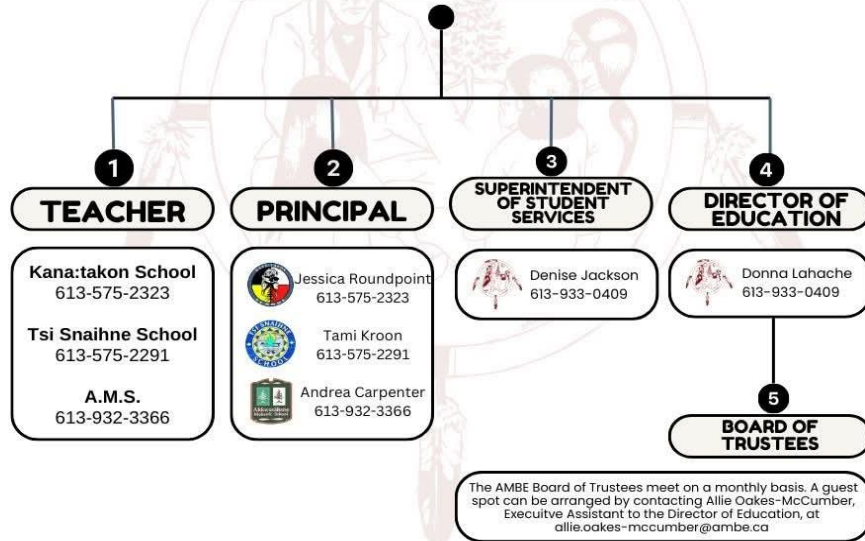

TEMPORARY WORKAROUND

- Client brings their Quebec requisition to MCA clinic.
- Our Providers transfer it to an Ontario requisition, allowing Life Labs to pick it up and process it.
- Results can be faxed anywhere with client consent from the medical clinic.
- Clients can request a copy of their blood work from the medical clinic.
- Client should confirm with their Quebec Providers office that the results were received.
- MCA will also call the Quebec Provider to verify receipt.

ALTERNATIVE OPTION

- Clients can use their Quebec requisition directly at a Quebec lab.
- Medical transportation may assist in bringing clients to the nearest Quebec lab.
- Quebec labs are in: Ormston, Huntington, and Valleyfield

Here's a recap of notable events from **November 29th-December 31st, 2024**

- Attended all weekly council meetings, met with community members on various concerns and issues throughout the month of December.
- Attended the Assembly of First Nations (AFN) Special Assembly in Ottawa as part of ongoing engagement with the Iroquois Caucus and broader First Nations leadership. Key topics and presentations addressed issues critical to Akwesasne and other First Nations communities, focusing on protocol agreements, legislation, and resolutions across several priority areas.
 - Key Highlights:
 1. Iroquois Caucus Presentation
 - Protocol Agreement:
 - Presented the importance of improving the Protocol Agreement between the Iroquois Caucus (IC) and AFN.
 - Stressed that AFN must recognize the unique issues and concerns of individual First Nations, emphasizing that “not every First Nation is the same.”
 - Addressed shortcomings in collaboration and encouraged AFN to co-develop solutions tailored to specific community needs.
 - UNDRIP Action Plan:
 - Highlighted language concerning border rights and challenges faced by border communities.

- Discussed incorporating actionable commitments into the UNDRIP framework.
 - Noted two resolutions slated for discussion at the General Assembly related to these issues.
- 2. Child Welfare Act and National Chief's Address
 - The National Chief attended the Iroquois Caucus session and provided insight on the Child Welfare Act, which was denied by vote.
 - Called for parliamentary reform, citing a lack of transparency and accountability in legislative processes impacting First Nations.
- 3. Assembly Resolutions
 - Infrastructure and Economic Development: 4 resolutions discussed.
 - Citizenship: 2 resolutions presented.
 - Land, Rights, and Justice: 7 resolutions deliberated.
 - Health, Healing, and Justice: 10 resolutions tabled, reflecting significant focus on addressing health disparities and justice reforms.
- 4. Key Updates and Discussions
 - Jordan's Principle:
 - Dr. Cindy Blackstock provided updates on the principle and emphasized the need for longer-term reforms for First Nations child welfare systems.
 - Guest Speakers:
 - Jagmeet Singh (New Democratic Party Leader), Patty Hajdu (Minister of Indigenous Services Canada), Dan Vandal (Minister of Northern Affairs), and Prime Minister Justin Trudeau shared insights on policy directions, funding, and federal commitments.
- Next Steps:
 - Monitor progress on the resolutions discussed, particularly those related to border rights, health, and child welfare reform.
 - Continue advocacy to ensure AFN and federal leadership prioritize issues uniquely affecting border communities like Akwesasne.
 - Engage with stakeholders to advance actionable components of the UNDRIP Action Plan in alignment with community priorities.
- Participated in the annual Community Holiday Dinners hosted across the three districts of Akwesasne. These events brought together community members to celebrate the season and foster a sense of unity and gratitude. Districts: Kana:takon - December 9th, Kawehno:ke -December 11th, and TsiSnaihne- December 12th each hosted a holiday dinner.
 - Council Participation: Council members actively served meals, reinforcing our commitment to community engagement and support.
 - Catering: Meals were prepared and served by various local caterers such as TNT, LaToya Rourke and Ramona Shenandoah.
- I had a meeting with the Hydro Quebec working task group on December 12th.

- On December 13th - Attended an information and transitional meeting facilitated by Deloitte and the new trust oversight body. The session served as an orientation for new members of Council and a refresher for returning members, ensuring continuity and understanding of trust operations and governance.

Some Key Details:

- Deloitte provided expertise on trust oversight processes, financial accountability, and governance frameworks.
 - Orientation for newly elected Council members to familiarize them with trust management and oversight responsibilities.
 - Refresher for returning Council members on operational updates and governance principles.
 - Review of the trust's structure, purpose, and management.
 - Emphasis on transparency, accountability, and community benefit.
 - Discussion of roles and responsibilities for Council in trust oversight.
 - Ensured all Council members are equipped with the knowledge to uphold trust, integrity and fiduciary responsibilities.
 - Strengthened collaboration between Deloitte, trust oversight, and Council for improved governance practices.
- The Tsi Snaihne District Meeting was held on December 23, 2024, with approximately 15 community members in attendance. A Program Manager, who is also a community member, provided a presentation detailing the history and operations of the program. The presentation covered key topics, including the service complaint policy and procedures, Jordan's Principle, the Akwesasne Heating Assistance program, and the Special Needs Committee

- I attended The Akwesasne Police Commission portfolio meeting on December 10th. District reports of any issues/solutions.

Partnership between OPG and MCA (POM)

- OPG Updates
 - New CEO, Nicole Butcher, starting on January 1, 2025. Nicole has been with OPG for over 20 years. She is replacing Ken Hartwick.
 - Projects still in development – the Independent Electricity System Operator (IESO) has released a fresh electrical demand forecast and it is closer to OPG

projections. It is a public document. By 2050 the report says that our energy demand will double. OPG will share the document.

- OPG Darlington refurbishment continues – 3 of 4 units are complete. This was done on budget and on schedule
- Pursuing a small modular reactor (300 MW) by 2030. Will be looking to hire operators and maintainers in 2025. Currently doing site prep, installation to start next year.
- Ontario announced 3 sites that they support for further development.
- Pickering nuclear A side reactors will be shut down and B side reactors will be studied for continued work.
- A lot of upcoming demand for electricians, iron workers, construction, and millwrights.
- Akwesasne and POM are invited to tour a nuclear site if there is interest.
- Head Office does corporate strategy and looks into energy projects, if there is interest or a need, OPG would be happy to connect us with this group.
- Pursuing hydro generating, greenfield sites, in the north of the province. Bruce Robertson is involved in these early discussions with First Nations communities near Timmins.
- OPG Board of Directors approved the rebuild of two hydroelectric sites.
- Will be developing Little Jackfish site, located north of Lake Nipigon, and communicating with neighboring First Nations communities to see if there is interest.
- There is a security project on site resulting from an incident last year. So far this has included fencing at the flags on the dam, and more security on site. Will be installing cameras.
- A variety of concrete projects are ongoing. Currently working to fix beams.
- The ice booms were installed near Johnstown/Prescott. Looking to redesign these booms. They were previously wood. Contracts will be posted in the next couple of years. If there are contractors in the community OPG can work to include them through a variety of methods. These booms help to maintain water flow.
- Amanda Greener in projects and construction can come to present the future projects. Since there is an interest Amanda Greener can join POM as a regular member. The POM agreed to add Amanda Greener as a regular POM member.
- Boating gates are closed until spring.
- Operations are currently at normal flow with 12 turbines operating

Department of Health:

- Discussed, the opening of the Tsi Snaihne Medical Clinic will be open January 22nd at Iakhihsohtha Elderly Lodge. There will be a ribbon cutting. The clinic will be a 15-minute appointment in rapid response, this is only a temporary location until the Sunday Warehouse renovations are complete.
- DOH Priorities Survey will be available in January, and 740 people responded to the survey.
- Akwesasne Non-Insured Health Benefits have discussed the changes coming, more community engagement session and will have the Director, Assistant Director and Sectors Managers in attendance to address the concerns/issues the community has.

- January 7th -Attend the Border Partners Meeting with CBSA, US Customs, Saint Regis Mohawk Tribal Council and MCA Council of Chiefs topics discussed were the reduction of the hours at the other smaller ports, there will be no remote clearing and reduction of the staff. Assistance with the team from MCA DCSS on the ham/turkey giveaway. Discussed community events that will be occurring in Akwesasne that will be bring first nations from other territories for mid-winter ceremonies, Iroquois Caucus general assembly and other events.
- January 10: Participated in the Circle of Leaders event hosted by JT *Business Services*. This comprehensive leadership training included:
 - Exploring key characteristics of effective and adaptive leadership.
 - Understanding the distinctions between management and leadership approaches.
 - Completing a personality dimensions assessment to enhance self-awareness and team dynamics.
 - Analyzing generational differences (Gen Z, Millennials, Baby Boomers, etc.) and their influence on workplace culture, communication styles, and collaboration.

- Discussions and activities focused on fostering a cohesive and inclusive work environment across generational lines.
- January 15-17: Attended the Iroquois Caucus General Assembly held in Akwesasne. The meeting focused on the strategic plan, covering key topics such as each First Nation’s political overview, issues and priorities, key objectives, mandate letters, and next steps for implementation. Participating First Nations included Kahnawake, Kanesatake, Tyendinaga, Six Nations, and Oneida of the Thames.
- January 21: Attended the SRMT/MCA leadership meeting, where key discussions focused on fostering a lateral kindness initiative between both organizations, establishing a waterline interconnection for emergency situations, and addressing flooding issues caused by beaver damming in the Cook Road, Drum Street, and TsiSnaihne areas. Proposed solutions included coordinating ditch clearing efforts and installing "beaver deceivers" to mitigate future flooding risks. Updated on the new construction project for the Akwesasne Mohak Ambulance on State Route 37. This new renovation project will have 2 office rooms, kitchen area, garage and laundry area.
- January 23: attended the swearing ceremony for the Tsikaristisere Trust Signing of the newly appointed trustees at the TsiSnaihne Recreation Center.

This monthly report is provided as part of Council's aim towards providing a transparent and efficient governing system, which will also provide information to members of the community on updates of Mohawk Government, Portfolios, and Monthly Activities.

Monthly Notables:

November 27th: Nation Building held an all-day Enforcement Symposium. This meeting brought together representatives from various MCA programs to discuss the challenges of enforcing Akwesasne laws, by-laws, and court orders, and to explore ways to improve enforcement processes. Enforcing laws and regulations in Akwesasne has been challenging due to a lack of effective tools and systems. This complex issue requires input and collaboration from multiple departments within the Mohawk Council of Akwesasne. To address these challenges, departments must work together to find new approaches that meet the community's needs. A technical team has been formed to examine these issues and begin developing solutions. The ultimate goal is to create an Enforcement Action Plan. This plan will set out clear objectives and practical steps to tackle enforcement challenges, using a phased approach to ensure steady progress and long-term improvements.

November 28th: Department of Social Services Portfolio, discussed several key community projects and updates. Highlights included the start of a multi-trades program at Iohahi:io, plans for the Iakhihsohtha kitchen renovations, and ongoing work on the Saint Regis Beach project. Updates were provided on the shelter and transitional housing programs, including renovations to the teaching kitchen and plans for a mini home to support men at the shelter. Discussions also covered the development of a youth hub, ensuring inclusivity for special needs and providing transportation for youth aged 0-26. Progress continues on these initiatives to meet the community's needs and improve services.

November 28th: we held our General Meeting, where the main discussion focused on Land Claims. Lawyer Frank Holloman joined us via Zoom to provide a detailed presentation and answer questions from the community. This session allowed for valuable dialogue and clarification on this important issue.

December 2-5th: Assembly of First Nations (AFN) Special Chiefs Assembly held in Ottawa, ON Rogers Centre

December 2nd: Concurrent dialogue sessions throughout the day.

I attended the session on the economic impact of closing the infrastructure gap and it highlighted how investing in infrastructure can greatly improve the economy and quality of life. For example, the Assembly of First Nations estimates that closing the infrastructure gap for First Nations by 2030 could boost the economy by \$635 billion, create over 338,000 jobs per year, and generate \$87 billion in government revenue over seven years. On a global scale, the World Economic Forum notes that addressing the \$15 trillion infrastructure gap by 2040 is essential for improving competitiveness and raising living standards. These discussions emphasized the importance of making smart infrastructure investments to benefit communities and drive economic growth.

The second dialogue session I attended, Bridging Gaps: Aligning the Non-Insured Health Benefits Program (NIHB) with First Nations Experiences and Disability Inclusion, focused on improving health services for First Nations communities. The discussion emphasized the importance of tailoring programs to meet the unique needs of these communities, especially individuals with disabilities. Key topics included expanding NIHB coverage to include allied health services like physiotherapy, speech therapy, and audiology, promoting fair access and holistic wellness. The session also addressed barriers in the NIHB Medical Transportation Policy, calling for the removal of discriminatory rules impacting off-reserve members. Recommendations highlighted the need for systemic improvements, collaboration with healthcare providers and government authorities, and securing funding to support these changes, ensuring equitable access to health benefits and services.

The third dialogue session I attended was focused on Income Assistance and Poverty, titled 'From Surviving to Thriving'. It discussed reforms to the Income Assistance (IA) Program, with a key focus on aligning it with the unique realities and needs of First Nations communities. The conversation emphasized moving towards a needs-based funding model that accounts for factors like remoteness, inflation, and cost of living. The session also highlighted the importance of building a First Nations social safety net that provides holistic, wrap-around supports to reduce poverty and support thriving communities. Recommendations included strengthening data collection to inform evidence-based funding, improving infrastructure to deliver services, and ensuring inflation relief continues until IA rates match the cost of living. Additionally, work is ongoing to develop First Nation-specific indicators for poverty and wellness, shifting from financial-based measures to a culturally appropriate approach. The importance of collaboration between First Nations, government, and organizations was emphasized, with a focus on long-term investments and sustainable change.

In the evening, I attended a Chiefs Committee meeting. While I am not a member of the committees, I had the opportunity to sit in on the Women's Council meeting. It was insightful to observe the discussions and gain a deeper understanding of the priorities and initiatives being addressed by the Women's Council. During the Women's Council meeting, National Chief Cindy

Woodhouse was in attendance to listen and engage with the council on several urgent topics. Key discussions included addressing the ongoing crisis of Missing and Murdered Indigenous Women (MMIW), the implementation and challenges of Jordan's Principle, and critical reforms related to child welfare. These discussions underscored the importance of advocacy and collaboration to address these pressing issues impacting First Nations communities.

The Special Chiefs Assembly, held December 3-5, 2024, focused on critical topics affecting First Nations communities, including infrastructure, child and family services, justice reform, health, and economic development. Discussions included resolutions on expanding health benefits, addressing systemic issues like human trafficking and anti-Indigenous hate speech, and ensuring equitable support for Jordan's Principle and child welfare reforms. Regional Caucuses were held each morning at 7:30 to provide an overview of the day's resolutions and address any questions. These sessions ensured that everyone was on the same page and fully prepared for the discussions ahead. I attended the Ontario Caucus as part of the Chiefs of Ontario Economic Development Table, while the Grand Chief represented us in the Quebec Caucus. These caucuses fostered collaboration and unity, setting the stage for productive discussions throughout the Assembly.

December 9th: All day Council Meeting.

Started off with our Holiday Meals in Kana:takon, the dinner was catered by TNT Deli, it was a great time seeing everyone and wishing everyone a happy holiday.

December 10th: I spent the morning in the office until 11:30, then headed down to Iakhihsohtha to participate in a door judging event. After enjoying lunch, we were tasked with selecting winners for different categories. All the doors were so creative and beautifully decorated, making it a tough decision to choose the best ones. A big congratulations to everyone involved; it was a fantastic event, and the effort put into it really showed!

December 11th: I spent the day in the office, and in the evening, I attended the Holiday Dinner in Kawehno:ke, catered by TLC Catering (LaToya Rourke). It was a wonderful event and such a joy to see everyone come together to celebrate.

December 12th: I spent the day in the office, and in the evening, we held our final Holiday Dinner for Tsi Snaihne, catered by Mona Shenandoah. Due to events happening in the area, we, as Council, decided to make the dinner takeout to prioritize the safety of the community, even though we would have loved to host a sit-down gathering. A heartfelt Nia:wen to our first responders for their efforts in keeping our community safe.

December 13th: I recorded a greeting video for the opening ceremonies of the World Juniors happening in Ottawa. I'm thrilled to be part of this exciting event, especially as our very own Carey Terrance Jr. is representing Team USA. It's an incredible moment for our community and I'm so proud of Carey's accomplishments. Wishing him and all the players the best of luck!

DCSS Portfolio Meeting focused on key community initiatives and updates. Discussions included resolving medical billing concerns for children in care, addressing shelter camera issues at the AFWP building, and ensuring long-term family accommodations. The meeting highlighted lobbying efforts for property to support men's programming, addiction services, family unification, 2SLGBTQ+ child services, increased low-income housing, and a proposed building for the arts. These efforts aim to strengthen community support systems and address critical needs.

In the afternoon, I spent the rest of the day at the Kana:takon Recreation Center for the kickoff of their "A December to Remember" event. It was heartwarming to see the community come together to celebrate the holiday season and enjoy the festivities. On Sunday afternoon, I returned to the recreation center to help out in the kitchen. It was a rewarding experience to support the event and contribute to such a joyful community gathering.

December 16th: we held our Council meeting, where we received the somber news of the passing of past Chief Tim Dooley Thompson. Despite the heavy hearts, we completed the scheduled presentation and MCRs before concluding the meeting for the day. Our thoughts are with his family and loved ones during this difficult time.

December 18th: In the morning, I attended the Economic Development Portfolio meeting at the Anowarakowa Arena, where we discussed key community priorities, including the Quebec Protocol Agreement, Indigenous procurement, and the FTTH project. These discussions focused on strengthening our community businesses, strategies, and overall direction. I had to leave the meeting early to attend my daughter's Christmas concert at Kana:takon School, which was a wonderful event. After the concert, I returned to the office to continue working for the remainder of the afternoon.

December 19th: we held our Health Portfolio meeting, where we had meaningful discussions on several key topics, including nursing salary compensation, the upcoming opening of the Tsi Snaihne Medical Clinic on January 22nd, and updates on Akwesasne Non-Insured Health Benefits and additional community support. We also focused on enhancing elder services and fostering greater community engagement. There was a strong emphasis on including services for individuals with diverse abilities, expanding mental health supports, and scheduling table talks during evenings to accommodate more community members. Additionally, we discussed ways to improve communication about the various health sectors and the ongoing lobbying efforts needed from Portfolio Chiefs to support the department's initiatives.

December 23rd: All day Council Meeting and Tsi Snaihne District Meeting.

Dan Bruyere was invited to discuss the Community Support Program, which led to productive dialogue. Many questions were answered, and the community expressed enthusiasm for additional programs and for attending future district meetings. The meeting also addressed the critical issue of Aboriginal lateral violence, underscoring the importance of fostering open communication within the community. Concerns were raised about the land claims process and achieving

community consensus, highlighting the need for improved information sharing and increased engagement, particularly with the youth.

January 3rd: Tsi Snaihne District Chiefs had a meeting to discuss future office hours within the district, planning and review of how our district meetings are. Key actions were to review communication protocol, addressing community engagement through structure meetings, including youth sessions.

January 6th: All day Council Meeting and AMPS Strategic Planning Session in Tsi Snaihne. The AMPS Strategic Planning Session focused on finalizing a comprehensive strategic plan with four key priorities: community focus, enhanced safety, building capacity, and sound governance. The session emphasized the importance of community consultation and collaborative policing strategies aimed at building trust, addressing visibility challenges, and enhancing youth and elder engagement. Discussions included adopting a prevention-based safety approach using technology and data, as well as tackling recruitment and retention challenges within the police force. The importance of transparency, accountability, and fostering a culture of integrity in governance was also highlighted. Community concerns were addressed, including human smuggling and drug trafficking, leading to specific action items aimed at innovative recruitment, improved response communications, and enhanced mental health response capabilities. A validation exercise welcomed community feedback on the strategic plan, culminating in several proposed initiatives to strengthen community partnerships and outreach efforts while addressing the needs of vulnerable populations.

January 7th: Attended via Zoom the Boarder Partners meeting that included meet and greet with Northern Ontario Region, newly appointed RDP Jag Johnston. Discussions included fostering collaboration among participants, new safety enhancements (new speed bump on US side). Community updates highlight upcoming cultural events and training including visibility improvements for road safety.

January 8th: Finance Committee Meeting- Attended the Finance Committee meeting, where we reviewed the budget that will be presented at a future General Meeting. It was also discussed that there will be postings for additional community members to join the Finance Committee; if you're interested in joining, please don't hesitate to reach out.

January 9th: Internal CBSA Meeting- The discussions focused on the various circles that past Chiefs were part of Chiefs that are on the committee members were encouraged to express interest in joining any of these circles. The meeting also addressed the creation of a Dundee Port working circle, which was prompted by a land claim settlement, and provided updates on the active Community Relations and Cornwall Port of Entry circles. The importance of strong leadership within these circles was emphasized.

January 10th: Attended an all-day training at the HUD- Circle of Leaders hosted by JTBS focused on building effective leadership skills and strengthening team dynamics. The workshop covered a variety of topics, including understanding how leadership styles impact teams, discovering individual communication styles, and exploring the concept of Color Motivators. We also learned techniques for giving meaningful appreciation and feedback, improving delegation skills, and navigating change as a leader. The day was filled with engaging discussions, practical tools, and opportunities for personal growth.

January 13th: All day Council meeting held at the Kana:takon Recreation

January 15th: I attended the First Nations Women's Council Orientation via Zoom, where Nancy Johnson, the Director, and her team provided an overview of the roles and responsibilities of the council. The session focused on key priorities such as community safety, well-being, and efforts to end violence against First Nations women and girls. Nancy also discussed the development of a Gender-Based Violence Action Plan and the establishment of a Two-Spirit Council to address these critical issues.

January 16th: During the Department of Health's January 2025 Monthly Portfolio Meeting, several important updates were shared. These included new access to dialysis for Quebec residents and the opening of a medical clinic in Tsi Snaihne. Infrastructure needs were also highlighted, such as the need for more nursing facilities and better support for young adults with special needs.

- Attended AFN Special Chiefs Assembly December 3-5. I attended via zoom for December 3 as well as 5. December 4th Lisa Francis Benedict and I travel to Ottawa for the day and attended in Person.
- Attended the Kana:takon District Christmas Dinner at the Kana:takon Recreation on December 9 December 11 at the Cornwall Island Recreation and December 12 at the Snye Recreation. All Holiday Dinners were very well attended by Community.
- Attended the Kanatakon Recreation Christmas to Remember fundraiser December 13,14,15 as Laura Thompson and her family as well as the Kanatakon Recreation crew did a fantastic job.
- Attended Akwesasne Strategic Planning Community Session at the Kanatakon Recreation.
- Attended the Circle of Leaders training, this was good training as it gave you some tools to help work with others in your workplace who may have differing personality types as you. It was interesting to see what approaches to take when dealing with others.
- Kanatakon District Meeting was held January 20, 2025, at the Kanatakon Recreation with only one community member in attendance.
- Attended a meeting with the Saint Regis Mohawk Tribe on January 2, 2025, regarding us working together on some possible upcoming initiatives. These meetings will take place quarterly with the next meeting scheduled in April.
- Attended the Tsi Snaihne Clinic Ribbon Cutting Ceremony. The Clinic is now open to the community members. This is a great step forward for the health of our community with the ability to access clinical services in all three districts.

- The Dundee Trust signing took place on January 23, 2025. The trust officially has all its members. The community was able to partake in a meal as well to watch the event.
- Attended the Beans movie showing at the Aultsville Film Festival in Cornwall. This event had a great turnout. It was beautiful to see our very own Kiawentiio Tarbell as the star of the movie. She is an amazingly talented young lady.

Public Safety- Akwesasne Mohawk Police presented their Strategic Plan to the Community in all three districts. This took place January 6,8,9 at all three district recreation centers. A to Z was present to answer any questions about the strategic plan and to take all feedback into consideration. Currently there is an online survey so community members can share their feedback so that AMPS can understand the current needs of the community. The survey will end on January 30, 2025. I attended Police Commission meetings on behalf of my district and brought all community concerns to the meeting. We have an upcoming Portfolio meeting on January 31, 2025

Justice- Space needs continue to be a concern for our Justice Department, this is currently being assessed and hopefully a solution is in the very near future as they wait for the Sunday Warehouse building to be complete. The legislative oversight committee now has all members and has begun meeting. I have attended both of the scheduled meetings, and I will be sitting on the residency law as well as the Child Rights Law. The Oversight Committee on Legislative Development (OSC) is requesting feedback from community members to determine which three Akwesasne Laws should be prioritized for 2025. Each year, the OSC collaborates with the Akwesasne Justice Department Portfolio Chiefs to identify, this survey will be available to the community online and your input is very valuable.

Economic Development- We had our first portfolio meeting where the Economic Development Director did an impressive job of highlighting all areas of her program. Connections are still taking place with Ontario East, and they are aware of those houses who are signed up but have yet to have a line dug to their home. In most cases these homes were difficult to access but they will be connected as soon as they can.

Department of Community and Social Services- The first nations child and family services Jordans Principle settlement will officially open for claims on March 10, 2025. The

Federal Court approved the First Nations Child and Family Services and Jordan's Principle Settlement Agreement on October 24, 2023. This agreement aims to provide compensation to individuals harmed by the discriminatory underfunding of the First Nations Child and Family Services Program and those impacted by the federal government's restrictive interpretation of Jordan's Principle. The \$23.34 billion settlement follows compensation directives from the Canadian Human Rights Tribunal in 2019, which investigated systemic discrimination against First Nations children and families.

1465 households benefited from the Akwesasne Heating Assistance Program. This funding has been dispersed to electric companies and fuel providers> Each household received 1500.00.

There has also been much concern about some of our homeless community members in the City of Cornwall. Community Support has reached out to them and provided backpacks with supplies as well as options were given on how community support can assist with shelter. There is also the Persian Manner in Cornwall where there are several rooms designated to Akwesasne residents.

Health- On January 22nd the temporary Snye Medical clinic opened its doors to the community. Blood Work Clinics are now available in all districts, locations are in Tsi Snaihne Medical clinic at Iakhihsotha lodge, Akwesasne Medical Clinic and Kawehno:ke Medical Clinic. Jordans Principles office will also have a Satellite office at the Snye Medical Clinic. Some changes have been made to the Special Need Policy Fund and now include members of Akwesasne who reside in the Cornwall area. Blood Work Clinics are now available in all three districts as well, this is also a huge step forward for our community's health needs.

Special Needs Committee: Chief Lacey, Chief Vanessa, Chief Teresa, and I have formed the Special needs committee, and we held our first meeting and discussed priorities in this area. We are lacking in this area, and I will not let special needs programming fall through the cracks. We need to make sure our community members' special needs are a priority and are well taken care of. I look forward to collaborating with the departments to help fill in the gaps that are present.

Youth Elders Language and Culture: We held our first official meeting on January 22, 2025, in which we discussed our plans moving forward with this committee. All youth council members have been accepted and an upcoming swearing-in ceremony will take place. Currently also looking at the process for an elders committee. We will be developing a charter and policies and procedures for this committee. We also spoke of some requests that have been brought

forward for language programs and a Request for Proposal will be going out to the community and the next couple of weeks.
